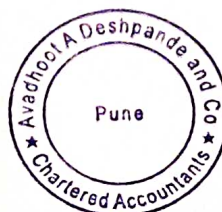

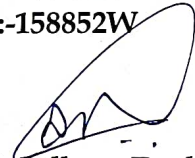

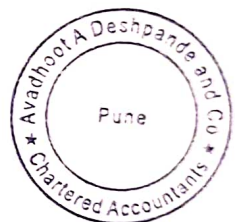

INVESTMENTS

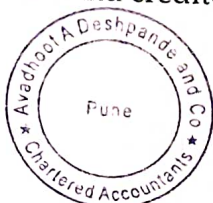
Investments are shown at cost.
